## THE NORMALIZATION OF FOREVER TIME

A July 2009 report released by the Sentencing Project (514 Tenth St NW, Suite 1000, Washington DC 20004, 202-628-0871, www.sentencingproject.org), No Exit: The Expanding Use of Life Sentences in America, states there are 140,610 people serving life sentences in state and federal prisons (this is one out of every 11 imprisoned people). Of these people, 6,807 were juveniles at the time the crime they were convicted of was committed. Of those doing life sentences, 29%--that is 41,095 people-have no possibility of parole and 1,755 were juveniles at the time of the crime. Currently in the United States there are 2.3 million people imprisoned. This is a 600% increase since 1972 and results in the U.S. having the highest incarceration rate in the world, That is, the number of people locked up considered as a fraction of the total population. Now in the U.S. that is over 750 out of every 100.000 people. And, as the Sentencing Project says, "Foremost among the changes affecting the prison population in recent years are laws and policies regarding the expansion of life sentences, particularly Life Without Parole Sentences (LWOP).

There are, as we know, overwhelming ethnic disparities in who receives these draconian sentences. Of all those sentenced to life, 66% are non-white; 77% of juveniles doing life sentences are non-white.

Four other major findings of the report are:

\* In five states: Alabama, Califòrnia, Massachusetts Nevada, and New York -- at last 1 in 6 prisoners are doing life sentences.

In five states: California, Florida, Louisiana, Michigan, and Pennsylvania -- each have more than 3,000 human beings doing Life Without Parole Sentences. Pennsylvania has the most juveniles--345 juveniles with Life Without sentences.

In six states: Illinois, Iowa, Louisiana, Maine, Pennsylvania, South

Dakota and the federal government-- all life sentences are imposed without the possibility of parole.

\* The dramatic growth in life sentences is not primarily a result of higher street crime rates, but rather of policy changes that have imposed harsher punishments and restricted parole consideration. The number of those doing Life Without (LWOP) increased by 22% from 33,633 to 41,095 between 2003 and 2008. This is nearly four times the rate of growth of the parole-eligible life sentenced population.

The highest proportion of life sentences relative to the prison population is in federal court sanctioned California, where 20% of the prison population is doing life sentences, up from just over 18% in 2003. Among these 34,164 life sentences, almost 11% are Life Without.

People of Color receive a highly disproportionate part of life sentences. Of those with life sentences, an average of two-thirds are non-white. In New York state, 83.7% of the life sentenced population is non-white.

There are 6,807 juveniles with life sentence. Of them, 1,755--25.8%-- have Life Without. The United States is essentially the only country with this sentence for this age group. It is in violation of various U.N. treaties and covenants as a result. Of juveniles sentenced to life, 77% are youth of color.

Of the under 10% of prison and jail prisoners who are women and girls, 4,694 are doing life sentences. Of female prisoners, 26.4% have sentences of Life Without.

The Coalition for Prisoners' Rights stands with the Sentencing Project in calling for the elimination of sentences of life without parole, and restoring discretion to parole boards to determine who receives paroles.

The number of people in the U.S. officially in poverty is now 45 to 50 million. And we know who goes to prison.

According to the June 2009 issue of California Lifer Newsletter (PO Box 687, Walnut CA 91788), CA state Senate Bill 434 will make it a misdemeanor punishable by fines up to \$5,000 for possession of a cellular telephone or accessory by a prisoner, or by a prisoner's visitor while being searched or going through a metal detector prior to a visit, or by a person who intends to give it to a prisoner.
