Dear Mr. Ahrens:

I pray this letter finds all the folks of the Real Cost of Prisons Project, are all in good health, spirit, and under the watchful, and loving care of the angels, of the all mighty Elohim [God], (3 JOHN 2, AND PSALM 34: 3-7).

The MAIN REASON THE NORTH CAROLINA DEPARTMENT OF PUBLIC SAFETY, DIVISION OF ADULT CORRECTION - PRISONS, DON'T LET ITS PRISON FACILITIES, DONATE THE EDIBLE VEGETABLES, (THAT ARE PLANTED, CULTIVATED AND HARVESTED BY THE INMATES), TO THE LOCAL SOUP KITCHENS, AND SO FORTH? IS THE DEPARTMENT OF CORRECTIONS, DO NOT WANT THE PEOPLE ON THE STREET, TO KNOW THAT THE BIGGEST SHARE OF ITS PRISONERS / INMATES, HAVE HUMANITARIAN FEELING, FOR THE DESTITUTED / POOR, PEOPLE IN THE OUTLYING COMMUNITIES! BECAUSE IT DOES NOT AGREE WITH THE DEPARTMENT OF CORRECTIONS' PRESUMPTUOUS IDEOLOGICAL REASONING, THAT ALL OF ITS PRISONERS, ARE CONVICTED "OFFENDERS", AND WILL ALWAYS BE RECIDIVIST "OFFENDERS"!

The NORTH CAROLINA DEPARTMENT OF PUBLIC SAFETY - PRISONS, ARE IN THE PROCESS OF CHANGING THE TITLE "INMATE(S)", TO THE INEQUITABLE DEROGATIVE AND/OR OFFENSIVE TERM "OFFENDER(S)", ON/IN ITS DEPARTMENTAL FORMS AND/OR DOCUMENTS. THEREBY FURTHERER DEGRADING, AND DEHUMANIZING, ITS INMATE POPULATIONS, IN THE EYES OF THE COMMUNITIES.

ON JULY 7TH, 2020, I FILED A Code 42 Section 1983, CIVIL COMPLAINT FOR INJUNCTIVE RELIEF, CASE NO. 5:20-CT-3220-FL, IN THE UNITED STATES DISTRICT COURT, FOR THE EASTERN DISTRICT OF NORTH CAROLINA. CONCERNING THE "NORTH CAROLINA DEPARTMENT OF PUBLIC SAFETY, DIVISION OF ADULT CORRECTION - PRISONS," [NCDPS-P], GOUGING MY [THE INMATES], TRUST FUNDS ACCOUNT, AT/FOR UNREASONABLE PERCENTAGE RATES OF 29% UPTO 98%, OF THE MONETARY FUNDS LEGITIMATELY DEPOSITED IN MY TRUST FUNDS ACCOUNT [TFA], FOR DEBTS OWED NCDPS-P, FOR MEDICAL TREATMENTS, AND/OR DISCIPLINARY INFRACTIONS IMPOSED.

WHEREAS, NCDPS-P WITHHOLDS ALL, BUT TWO DOLLARS, OF ANY AMOUNT OF MONETARY FUNDS DEPOSITED IN MY TRUST FUNDS ACCOUNT, FOR WHAT I OWE THEM. ONE CLEAR EXAMPLE IS: I AM A TEACHER'S ASSISTANT, AND EARN ONE DOLLAR A DAY, AND/OR FIVE DOLLARS A WEEK, AND, NCDPS-P, WITHHOLDS 60% (THREE DOLLARS), FOR DEBTS OWED IT. THAT LEAVES ME TWO DOLLARS A WEEK TO PURCHASE THE NECESSARY HYGIENICS, AND POSTAGE STAMPS I USE.

SINCE I EARN A GROSS OF APPROXIMATELY TWENTY-ONE-DOLLARS-FIFTY-CENTS, IN A THIRTY DAY PERIOD, I AM INELIGIBLE TO RECEIVE THE NCDPS-P, WELFARE AND/OR INDIGENT ITEMS, AND/OR, LEGAL AND PERSONAL POSTAGE STAMPS, THIS APPLYS TO ALL THE NCDPS-P, INMATE POPULATIONS.

BUT SAY I WAS A JANITOR AND EARN FORTY-CENT A DAY, AND/OR TWO-DOLLARS-EIGHTY-CENTS A WEEK, AND/OR APPROXIMATELY TWELVE-DOLLARS-FOUR-CENTS, IN A THIRTY-DAY PERIOD. NCDPS-P, WITHHOLD 29%, AND/OR EIGHTY-CENTS, FOR DEBTS OWED IT, AND I WOULD STILL BE ELIGIBLE TO RECEIVE THE NCDPS-P, WELFARE AND/OR INDIGENT ITEMS, AND/OR LEGAL AND PERSONAL POSTAGE STAMPS, THIS HAS BEEN GOING ON SINCE ABOUT 2003, AND NOBODY, (INMATE), HAS CHALLENGED IT IN THE COURTS.

ONE IDEA I PROPOSE IN THE ABOVE CIVIL COMPLAINT, IS THAT NCDPS-P, SHOULD BASE THE WELFARE/INDIGENT STATUS ON MY (THE INMATES), NET TFA, AND NOT THE GROSS TFA BALANCES.

THANK YOU VERY MUCH, FOR POSTING MY ESSAYS ON THE, "REAL COST OF PRISONS PROJECT, WEBSITE! BECAUSE IT LET THE PEOPLE ON THE STREET KNOW, WHAT REALLY IS HAPPENING BEHIND THE SECURITY FENCES TOPPED WITH CONCERTINA WIRE OF THE LOCAL PRISONS.
