SHORT TAKES FROM DIFFERENT LOCATIONS

WHAT IS MORE IMPORTANT

The federal courts, having ruled that the health care in California prisons is so poor that it violates the civil rights of those imprisoned there, have threatened to take money directly from the state treasury to fix the system. But in June, the state's current corrections secretary wrote the courtappointed receiver that the state "cannot afford" the \$1.9 billion he himself had agreed to the month before. The tentative plan had called for building two prison hospitals to house 3,400 prisoners. California has a \$24.3 billion budget shortfall. It is supposed to have \$1 billion for prison hospital construction from the 2007 budget.

JLWOP DEVELOPMENTS

In re Antonio De Jesus Nuñez,
CA(3) No.C040377 (April 30, 2009) 2009 WL
1154200, a decision of the California
Court of Appeals, found Nuñez' JLWOP
(life without the possibility of parole)
sentence violated the Eighth Amendment.
He had been convicted of committing a
kidnaping for ransom when he was 14.
Similar offenses and sentences were
compared and the Lynch criteria applied.

A proposed new law in California would allow LWOP sentenced people whose convictions concern events that occurred when they were minors, to petition for resentencing under certain conditions. SB 399, passed by the Senate, would amend Penal Code sec. 1170 to permit such people, who have completed at least 10 years of their sentences, to submit a petition for recall and resentencing on or after January 1, 2011. If passed, this bill would apply retroactively. To qualify under the proposed law, applicants must satisfy three or more of seven listed criteria including a conviction pursuant to a felony murder or violent juvenile felony adjudications

FEDERAL AMICUS BRIEF

This was filed in the U.S. Supreme Court requesting certiorari on behalf of Families Against Mandatory Minimums and others in the case of Sabil Mujahid v. Charles A. Daniels, Warden, FCI Sheridan OR, No. 05-8678. The case affects about 95% of federal prisoners sentenced since 1987. The Brief concludes: "The BOP's calculating good time credits based on time served, rather than following the clear statutory language determining good time credits based on the sentence imposed, creates a significant loss of . human freedom and a great unnecessary monetary cost. This Court should grant review to decide this issue of great national importance and determine whether the BOP approach is consistent with the federal statute's mandate." The current BOP regulation means that every eligible federal prisoner is imprisoned seven days more per year than Congress intended.

NEW PRISON PHONE SYSTEM

The Texas Department of Corrections, under contract with Embarg, is finally installing a system wide phone system. Embarg employees reported that very few family members have signed up for the phone system which "makes it difficult" for Embarg to finance the installation of the phones. Each prisoner allowed to call. 10 phone numbers. In order to be approved on a prisoner's calling list, your phone number, landline only, along with your name as it appears on your driver's license, must be sent to the person whose calling list you want to be on. Everyone on a prisoner's calling list must register with the phone vendor, using the prisoner's TDCJ ID number, either at: www.texasprisonphone.com or at 1-866-806-7804. Everyone on a prisoner's calling list must be at least 18, have the name on the phone bill match their driver's license and NOT be using a cell phone.

Children and grandchildren of those exposed have severe physical deformities, mental and physical disabilities, diseases and shortened life spans.

The forests and jungles in large parts of southern Vietnam have been devastated and denuded. They may never grow back; to the extent they do, they will take 50 to 200 years to regenerate. Animals that inhabited the forests and jungles have become extinct, disrupting the communities that depended on them. The rivers and underground water in some areas have also been contaminated. Erosion and desertification are changing the environment, contributing to their warming of the planet and dislocation of crop and animal life.

Recently the Bureau of the
International Association of Democratic
Lawyers found the U\$ government and the
chemical companies guilty of war crimes,
crimes against humanity, and ecocide
during the illegal U\$ war of aggression in
Vietnam. Genocide by herbicide is the
crime this month. The chemical companies
like Mansanto and Dow and their servant,
the U\$ government, are the perps.
